# EES1123H Environmental Regulations

"This course will cover selected federal and provincial environmental regulations. Students will discuss key regulations with experienced practitioners and be taught the values, assumptions and guiding principles which underlie regulations as they relate to the environment. Federal and provincial regulations that will be discussed include environmental assessment, air quality and air emissions, contaminated lands and brownfields, water resources, fisheries, waste management, and other areas".

# COURSE OBJECTIVES:

The objectives of EES1123H (elective course for MEnvSc students) are to:

- provide an opportunity for students to become familiar with the statutes and regulations most commonly applied in environmental practice in Canada (Ontario);
  - inform students of available online regulatory resources for use in environmental science and professional practice;
- explore the background and development of key legislation affecting the environment.

By the end of the course students should expect to have:

- improved their understanding of the regulatory framework of environmental legislation in Ontario and Canada;
- gained experience in interpreting environmental regulations and their application;
- advanced their knowledge of key environmental legislation in a variety of applications and case study scenarios;
- compiled a personal catalogue of relevant environmental statutes and regulations;
- develop an ability to use a broad range of environmental regulations from across the spectrum of environmental conditions and scenarios.

### **TEXTS AND READINGS**

There is no required text for this course, but we may have readings assigned by speakers or the course instructor from time to time. It is expected that you will have read the assigned reading(s) prior to attending the class. Students who do not do the readings will find it difficult to follow the class material and will be challenged when completing assignments or exams. Additional suggested readings that you may find helpful for completing your assignments will be listed for you on Quercus when applicable.
